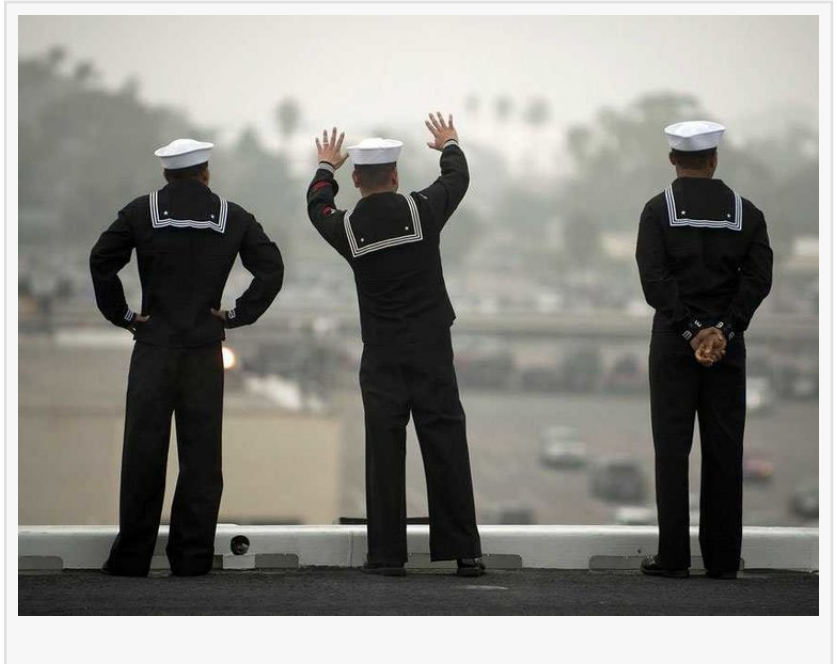

High risk occupations for exposure to asbestos in Montana include the US Navy, Malmstrom Air Force Base workers, 341st Missile Wing workers, miners, oil refinery workers, smelter workers, pulp and paper mill workers, welders,

plumbers, machinists, mechanics, insulators, construction workers, railroad workers and or former residents of Libby, Montana. www.karstvonoste.com/

According to the CDC the states indicated with the highest incidence of mesothelioma include Maine, Massachusetts, Connecticut, Maryland, New Jersey, Pennsylvania, Ohio, West Virginia, Virginia, Michigan, Illinois, Minnesota, Louisiana, Washington, and Oregon.
