Typically, asbestos exposure will have occurred sometime between the 1950s and the 1980s. Some of the most prevalent professions that encountered large quantities of asbestos include power plant workers, maritime workers, industrial workers, plumbers, pipefitters, electricians, mechanics, machinists, miners, railroad workers and construction workers, to name a few. Since the latency period for mesothelioma patients is approximately 40 years, most people diagnosed with mesothelioma or asbestos-related lung cancer in 2023 were exposed decades ago.

In 1894, Georgia became the first U.S. state to commercially mine asbestos. Northern Georgia is a mineral-rich area containing 17 former asbestos mines, most located in Rabun and White

counties. The abundance of natural asbestos in Georgia (third highest number of natural asbestos deposits in the nation) helps explain why so many industries in the state used asbestos during the late nineteenth and most of the twentieth centuries. Residents of Georgia who worked in or around shipyards, paper mills, power plants and military bases are at an elevated risk of developing mesothelioma or asbestos-related lung cancer.
